4. Any damages or consequential damages to the common or private property as a direct or indirect result of the improvements will be repaired and the costs thereof will be for the owner's account. These costs will be debited to the owner's levy account.
5. The Body Corporate accepts no responsibility whatsoever for any damages, losses, maintenance or for any other event to the installation/improvements, because of malicious damages or natural disasters or any other cause whatsoever. No claims can be instituted against the insurance policy of the Body Corporate whatsoever.
6. The Trustees reserve the right to inspect any improvements/alterations done to the common property or to sections and order any alterations/repairs/removal to the alterations/additions as they deem fit. The costs thereof will be for the owner's account.
7. Any additions/alterations are not covered by the standard buildings combined insurance policy and must be added by the owner, the additional premium therefore will be for the owner's account.
8. An owner will be held responsible for the maintenance of any alteration or improvement. If any repair or maintenance must be conducted to common property results in the damage of the alteration or improvement the repair cost will be for the owner or resident.
9. Where applicable the Trustees require that the owner submit the COC on completion of the alteration / improvement to the managing agent to be kept on file.
